EXAMINATION:
CT - THORACIC + LUMBAR SPINE

CLINICAL HISTORY:
Worsening back pain with radiation into the legs.

FINDINGS:
There is a mild-moderate thoracic kyphosis. No evidence of a vertebral lesion or compression fracture. No evidence of spondylolisthesis.
At C6/7 there is a central posterior osteophyte producing mild-moderate central canal stenosis.

Mild degenerative disc disease at T3/4 T4/5 T5/6 T7/8 T8/9 and T9/10. No evidence of a disc protrusion, central canal or foraminal stenosis in the thoracic region. Severe left T11 facet joint arthropathy. Mild bilateral T11/12 and T12/L1 facet joint arthropathy. Moderate bilateral T8/9 facet joint Arthropathy.

Moderate L3/4 and L4/5 degenerative disc disease. At L3/4 there is diffuse bulging of the annulus effacing the thecal sac anteriorly. At L4/5 there has been a laminectomy. No evidence of central canal or foraminal stenosis and in the lumbar region. Severe bilateral L5/S1 facet joint arthropathy. Mild bilateral L2/3 and L3 facet joint arthropathy.

A hypodense nodule is seen in the left thyroid lobe measuring 14 mm in diameter.

Conclusion:
Multilevel degenerative disc disease. Multilevel facet joint arthropathy. Severe bilateral L5/S1 facet joint arthropathy. If the patient's pain is limited to the lower lumbar spine then trial of bilateral L5/S1 facet blocks recommend. If required a bone scan with CT SPECT could localise possible symptomatic facet arthropathy.
