You will recall Jacqueline was referred with a right Bartholin's cyst. Her cycles have been irregular and her last period was in April last year.

A pelvic ultrasound was ordered to evaluate the uterus, tubes, ovaries, and endometrium as her cycles are irregular at 56.

Today's review is for results.

The recent pelvic ultrasound shows thickened endometrium at 7mm.

Jacqueline will undergo hysteroscopy and endometrial biopsy and LBC and removal of the labial cyst. The risks of the surgery have been explained to the patient and the surgery is booked at Wollongong Private Hospital. I will write to you following the surgery.

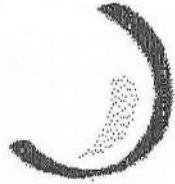

Study Date: 5th April 2024

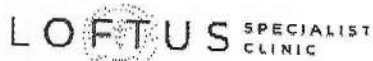
Clinical indication: irregular cycle. Patient states LMP 1 year ago.

A transvaginal, transabdominal, 3D and colour Doppler ultrasound was performed.

The uterus is anteverted to axial in position and measures 55mm in length (AP: 29mm; TRV: 37mm).

The uterine contours are normal in appearance.

The myometrium is normal in appearance.

The endometrium measures 7mm in combined thickness and shows normal appearances.
No unusual vascularity or intracavity pathology is seen.

Both ovaries are normal in size and location and the stroma of each ovary appears normal.
The left ovary measures 28mm x 11mm x 14mm (2.2ml in volume).
The right ovary measures 27mm x 12mm x 20mm (3.3ml in volume).

The uterus and left ovary demonstrate normal mobility upon palpation during transvaginal scanning.
The right ovary appears fixed in position with transducer pressure.
No areas of site specific tenderness were observed.
No abnormal adnexal masses or free pelvic fluid is seen.

COMMENT

If the patient is post-menopausal then an endometrial thickness of greater than 0.5cm is considered to be abnormal.
Further investigation is suggested.
Otherwise no unusual appearances are seen.
