ULTRASOUND LEFT SHOULDER

Clinical History:

Persistent shoulder pain.

Report:

There a full-thickness tear of the anterior and mid supraspinatus tendon measuring 14mm anterior to posterior, with 13mm tendon retraction. The subscapularis appears tendinopathic with some delamination present. No infraspinatus or long head of biceps tendon abnormality is detected. There is no biceps sheath effusion.

No abnormality of the posterior glenohumeral joint line is detected. There is a normal appearance to the acromioclavicular joint.

There is thickening of the subacromial bursa on arm abduction, which is painful. There is bursal bunching consistent with subacromial bursitis and impingement.

COMMENT:

Supraspinatus tendon tear associated with subacromial bursitis and impingement. A corticosteroid injection has been arranged.

Clinical Details:

?RCT ?Goitre.

Thyroid Gland Ultrasound:

Thyroid gland appears within normal size, echopattern and vascularity with no discrete focal pathology detected. Right lobe measures 43 x 16 x 13mm, left lobe 37 x 15 x 14mm and isthmus is 2mm in thickness. No solid or cystic neck mass lesion.

There is no obvious cervical lymphadenopathy.

Conclusion:

Normal thyroid ultrasound study.

Right Shoulder Ultrasound:

Full thickness tear anterior to mid supraspinatus tendon 20 x 16mm in size. Other tendons are intact. Subacromial bursa is markedly thickened. No joint effusion detected. Bursal impingement with abduction on dynamic examination.

Conclusion:

Large full thickness tear supraspinatus tendon.

Marked subacromial bursitis with impingement on abduction.
