Comments

Results consistent with adequate vitamin B12.

Active B12 is a better measure of Vitamin B12 sufficiency than the standard B12 assay.

Standard B12 assay assay values may be falsely low in oestrogen therapy, pregnancy, neutropenia and in inherited haptocorrin deficiency.

Testing of active B12 is routinely performed for people that have low or equivocal vitamin B12 results (<400 pmol/L) to clarify their B12 status. Both tests are Medicare rebatable. Those with vitamin B12 concentrations over 399 pmol/L are generally replete.
