In a follow-up to my prior correspondence, I saw Francois again today on the 1<sup>st</sup> of September 2022. He has had his right shoulder joint injection and thinks it may have helped a little bit although his arm felt numb for a little while it has now returned to baseline. He moves his shoulder around freely. His pain fluctuates from a 3/10 to a 10/10 with a very good physiological state despite the extreme levels of pain reported. He has been kindly seen by Dr. Peter Keogh, Pain Physician, who will again follow up with him tomorrow prior to Francois's discharge.

Francois will make follow-up arrangements with his orthopaedic surgeon. I have recommended following up with his prior neurosurgeons, Dr. Leon Lai, Dr. Ivan Bhaskar, or Professor Goldschlager, to whom he has been previously referred. I haven't made any routine arrangements to see him again.
