

According to the current Lipid Management Guidelines (2012) the suggested targets are: <4.0mmol/L Total Cholesterol (TC) <2.0mmol/L Triglycerides (TG) >=1.0mmol/L HDL Cholesterol (HDL-C) <2.0mmol/L LDL Cholesterol (LDL-C) The National Vascular Disease Prevention Alliance (NVDPA) guidelines recommend a target level of less than 2.5 mmol/L for non-HDLC. Compared to other lipid parameters, increased non-HDLC is the most significant marker for subclinical atherosclerosis. (ref: Cardiology Today 2013; 3(2): pp25-27). Please note: As of 25/11/2024 Capital Pathology has moved to using the Sampson equation for calculation of LDL-cholesterol levels. This equation now allows for calculation of LDL-cholesterol over a wider range than previously, up to a triglyceride value of 8.00 mmol/L.
