### **DNA Contamination in Covid vaccines: Momentum and traction with Australian Councils and TGA's response discredited**

Since the Town of Port Hedland passed its motion in October 2024, and I wrote to you providing our motion, many other Australian Councils and Councillors have taken similar action, all of which is to acknowledge concerns towards the DNA contamination in Australian vials and also Australian blood - Councils who seek answers from relevant authorities in Australia.

This email is to keep you informed of what Australian Councils have been doing and to also outline how the TGA's response about these concerns being 'misinformation' have been discredited.

I do not bring this DNA contamination issue to you lightly, I bring it to you as a concerned elected representative that feels a huge sense of duty to my very worried constituents. I have no axe to grind. I have no conflicts of interest in respect to the DNA contamination. And if this DNA contamination is evidence of mass-poisoning of Australians then bring right is a booby prize.

Excessive levels of DNA contamination have been proven in Australian vials of Pfizer and Moderna Covid-19 vaccines. What steps will you take?

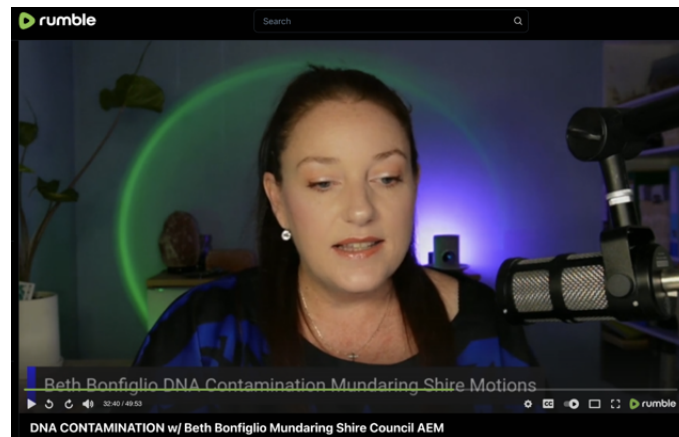
#### **1. Momentum and traction with Australian Councils**

Over recent months, residents across multiple local government areas have begun actively calling on their Councils to acknowledge and investigate the evidence of synthetic DNA contamination in the Pfizer and Moderna COVID-19 products.

At Electors' Meetings (AGMs) held this month, motions were passed in multiple jurisdictions demanding action from their Councils:

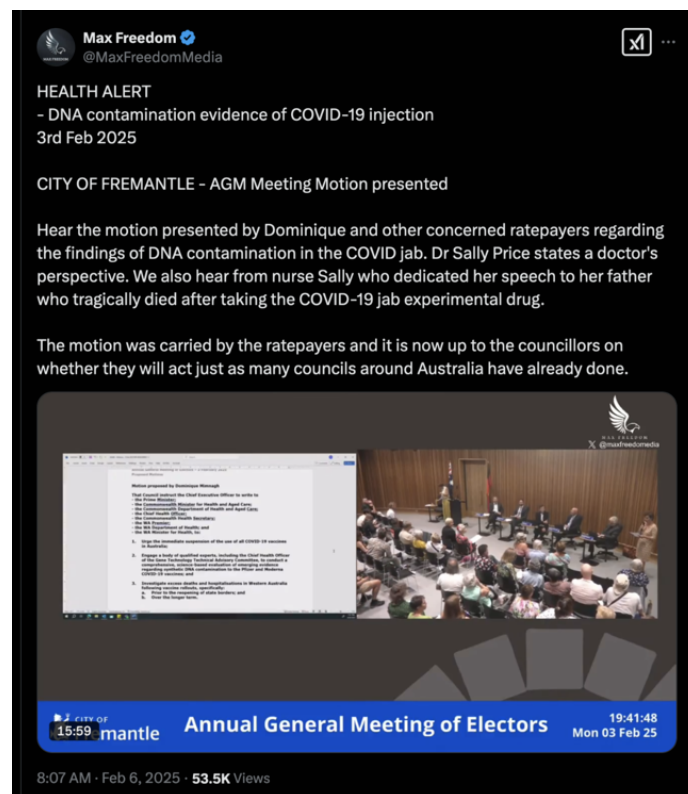
##### **1.1. Mundaring Shire Council (3 February 2025)**

Two motions were carried calling for the Council to table and discuss the growing body of scientific evidence regarding synthetic DNA contamination in COVID-19 products. Click the screenshot to watch the video.

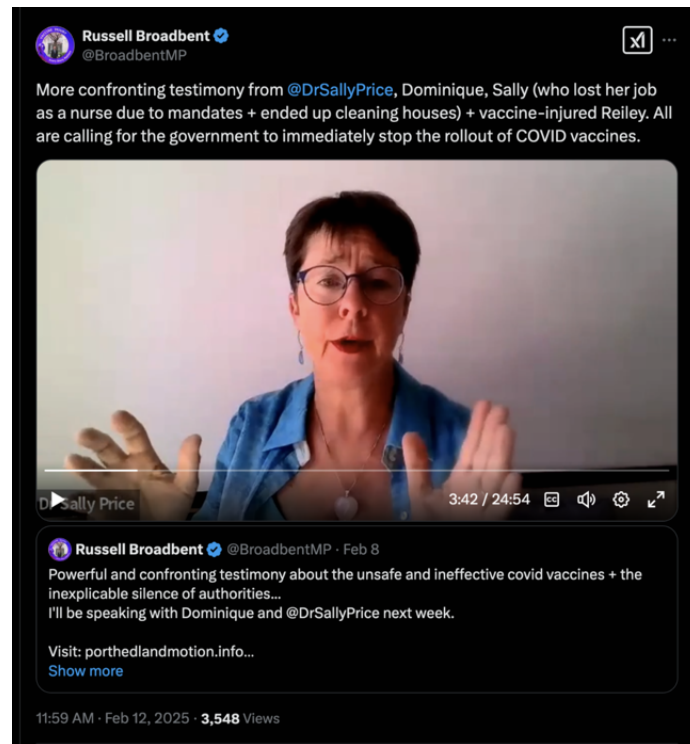


## 1.2. Fremantle Council (4 February 2025)

A motion was passed calling on the Council to acknowledge and discuss these serious concerns. Click the screenshot to watch the video.

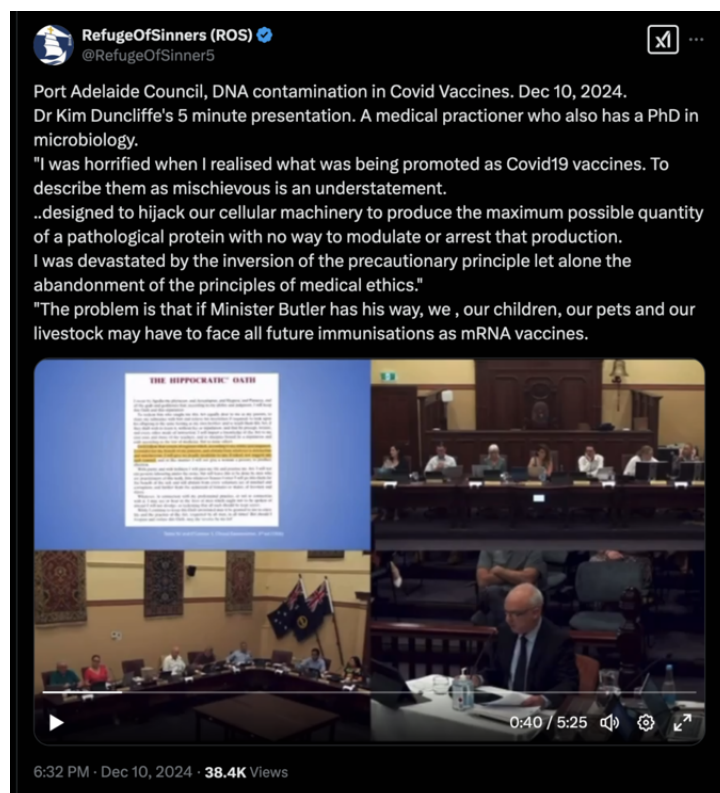


Following the Fremantle meeting Russell Broadbent MP interviewed key speakers Dominique Mimmagh, Dr. Sally Price, Nurse Sally McKay, and Covid-19 vaccine victim Reiley Paterson, who presented compelling arguments at the meeting.



### 1.3. Port Adelaide Council (10 December 2024)

Dr Kim Duncliffe provided 5 minutes of testimony concerning the dangers represented by the Pfizer and Moderna Covid-19 products, with especial emphasis on the consequences arising from the synthetic DNA contamination.



### 1.4. Port Macquarie Hastings Council (12 December 2024)

Councillor Hornshaw speaks to his Motion which notes receipt of the information shared by the

Town of Port Hedland Council on the synthetic DNA contamination, and thanks the Town of Port Hedland Council for taking the initiative. The Motion was passed.



To date five Councils have acted on the synthetic DNA contamination, with others soon to follow:



## 2. The TGA's Response to the DNA contamination being 'misinformation' has been discredited

Some Councillors have referenced the TGA's statement of 18 October 2024 alleging the scientific information on DNA contamination found in Australian vials is "misinformation."

**Russell Broadbent MP's letter to the Prime Minister on 29 October 2024** responded to this outlining that the TGA's statement contained multiple falsehoods, misleading claims, and scientifically incorrect assertions.

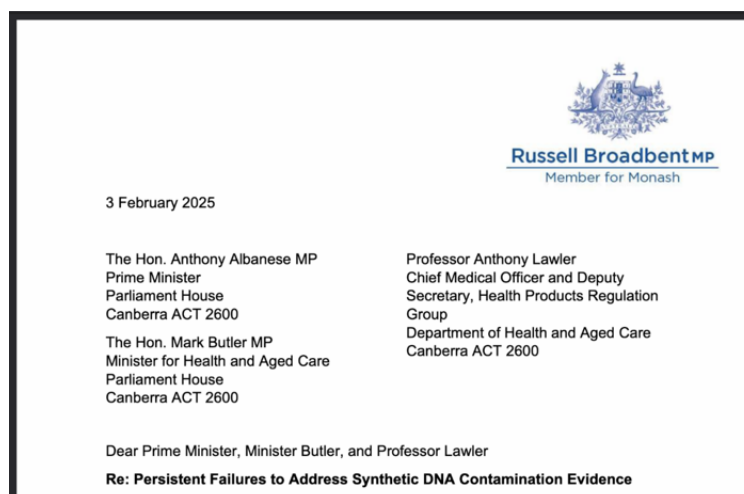
Dr. Maryanne Demasi, an investigative journalist and former ABC medical reporter, has now published a detailed exposé titled **Australian government branded a 'national embarrassment' over Covid-19 vaccines**, which highlights the government's continued failure to transparently engage with the mounting scientific evidence on synthetic DNA contamination. Dr. Demasi's article directly references Russell Broadbent MP's latest letter to the Prime Minister (3 February 2025), in which he exposes ongoing misrepresentations by the TGA and its refusal

to conduct basic, independent testing to confirm or refute the findings presented by multiple laboratories worldwide.



Mr. Broadbent's 3 February letter further underscores that the TGA, an agency overwhelmingly funded by industry fees—including those paid by Pfizer and Moderna—cannot be relied upon to provide an impartial assessment. This inherent conflict of interest, combined with the fact that the so-called experts advising the Minister of Health have repeatedly demonstrated a lack of relevant expertise, raises serious concerns about the government's ability and willingness to address this issue with scientific integrity.

### 3. As an elected representative of your people, what will you do?



The growing pressure local electors in Australia makes it clear that residents across Australia want their Councils to act, just as the Town of Port Hedland, West Tamar, Ceduna, Port Macquarie Hastings, and Port Adelaide Enfield have done.

Councillors in Mundaring, Bundaberg, and other Councils have personally reached out to request assistance in bringing similar motions forward - and are being provided with all necessary resources and support.

As elected officials, Councillors have a direct responsibility to their communities. This issue cannot simply be passed off to State or Commonwealth health authorities, especially now that:

1. Australian blood has been confirmed contaminated with synthetic DNA from Pfizer and Moderna vaccines.
2. 9 independent labs worldwide have now detected this contamination at levels far exceeding safety limits.
3. The Therapeutic Goods Administration (TGA) has failed to properly address this crisis and has been exposed for making misleading claims.

## What You Can Do

Local Councillors must:

1. Ensure residents and local health practitioners are informed so they can assess the risk profile for themselves and their patients.
2. Demand answers from their State and Commonwealth Health authorities - this is no longer a question of theory but a confirmed public health crisis.
3. Support motions in Council chambers replicating the Town of Port Hedland's Motion, to ensure this contamination is properly addressed at all levels of government.
