CT scan of the chest.

Clinical History:

History of possible pulmonary fibrosis.

Technique:

A standard CT has been performed with contrast. A formal HRCT has not been performed.

Comparison:

CT noted from October last year. See previous report.

Findings:

Pacemaker wires noted. Evidence of LAGB noted. No mediastinal lymphadenopathy detected. At the lung bases there is some patchy opacity as demonstrated previously. Changes more marked at the posterior aspect of the right lung base. A somewhat more extensive area of opacification extending over 2.2 cm noted postero medially at the right lung base. Present previously. Some distension of the distal oesophagus some air in the oesophagus. A gallstone noted in the gallbladder. Some cysts noted in the kidneys. No abnormality seen in the adrenals. No abnormality seen in the spleen. There is fatty infiltration of the pancreas. There are degenerative changes in the spine with some bridging osteophytes. There appeared to be some old left rib injuries.

There appeared to be some changes of gynaecomastia.

CONCLUSION:
