Biopractica Rejuvasleep Forte — DO NOT TAKE WITH MELATONIN			1-2 tabs 60 mins before bed (9pm for 10pm) – start with 1 tab for 3 days & if no effect take 2/night	Improve sleep onset & quality with natural melatonin
OptiActive D     Tablets	1 x day			Increase vitamin D levels to over 100 (currently 67, Dec 23)
Herbal Bitters     50ml	10-20 drops in 50ml water 2-20 mins before meals	10-20 drops in 50ml water 2-20 mins before meals	10-20 drops in 50ml water 2-20 mins before meals	Herbal bitters to help bile synthesis & release for better digestion
